# "The Story of the War of 1898"

Told by W. Nephew King, Lieutenant U.S.N.

One of the recent notable donations to the Boylston Historical Society and Museum is a first edition copy of "The Story of the War of 1898" told by W. Nephew King, Lieutenant U.S.N., published by Peter Fenelon Collier, New York in 1898. It was generously donated by Paul E. Freeman Jr. of Westborough, Massachusetts. Mr. Freeman is a 3<sup>rd</sup> generation descendant of Mr. James McGrath who was a resident of Boylston and one of the seven Boylston men who enlisted in the Spanish-American War.

In his historical essay 'The Waters Rose on the Earth' local historian George L. Wright depicts Boylston during the period of 1887-1906. He writes about the Spanish-American War as follows:

"On February 15, 1898 the battleship 'Maine' blew up in Havana harbor. The agitation of the Yellow Press and the many political 'hawks' forced this country into the Spanish-American War. On April 25, the Congress officially declared war on Spain, and the United States embarked on what Theodore Roosevelt called, 'that splendid little war.'

The following young men from Boylston enlisted in the military service: Anthony Newell [Nuell], Walter Stone, Ernest Whitcomb, James McGrath, Ralph C. White, Felix Smith, and Matthew Jasper. All of these men returned from the war, with no casualties reported."<sup>1</sup>

The Superintendent of the school district at the time was Charles L. Clay. He mentions in his annual report for the year ending in February 28, 1899:

"a period of time in which so many world-wide interests have hastened their culmination that history will doubtless record the year 1898 as the most memorable of the century now so near its close."..."The year has seen us in conflict, begun and ended, with one of the oldest nations of Europe. For the first time in our history, American soldiers have embarked for foreign lands."<sup>2</sup>

The donated book, *The Story of the War of 1898* by W. Nephew King, is bound in red, white and blue leather, and measures 13 5/8 x 20 7/8 x 2 ½ inches. It was restored by Old Working Books & Bindery, 18 Northfield, West Brookfield, Massachusetts. The cover and title page are designed by George Wharton Edwards.

The illustrations were selected and arranged by Walter Russell. The publication has 322 pages with 52 full-page black and white illustrations, 16 color illustrations of which 9 are large fold out illustrations, and numerous black and white photographs. The author's preface is followed by two introductions: an introduction for the Navy by Captain Robley D. Evans, and an introduction for the Army by Major-General O.O. Howard. These chapters are followed by the story of the war, written by Lieutenant W. Nephew King.

As the author writes in the preface, "This story of our 'Hundred Days' War with Spain' was prepared, not with a view of making it an exhaustive history, but, as the title itself suggests, an authentic narrative of our brilliant victory. The illustrations which adorn its pages are not only the work of well-known military and naval artists, but were mainly executed by eye-witnesses of the events portrayed, and no expense has been spared in their reproduction - both in colors and in black and white."<sup>3</sup>

James McGrath was one of the photographers whose photographs are included in this book. Mr. Freeman indicated that the name James McGrath is not listed among the photographers cited in the book, since he was an assistant to the photographers. The original photographs of San Juan Heights and others, were among those found in his personal collection.<sup>4</sup> James McGrath enlisted in the Massachusetts 9th Volunteer Infantry Regiment, Company G.



The 9<sup>th</sup> Massachusetts Volunteer Infantry was mustered in between 9th-12th May 1898 at South Framingham. At the time of mustering-in the unit had forty-seven officers and 896 enlisted men.<sup>5</sup> From Camp Dewey in South Framingham, the regiment went to Camp Algers near Falls Church, Virginia. The regiment, led by Colonel Fred B. Bogan, was sent to Cuba on 26 June and arrived on 1 July 1898. The regiment arrived the same day the battles of El Caney and San Juan Heights were fought.

"During the night of July 1<sup>st</sup>, the Thirty-fourth Regiment of Michigan Volunteers and the Ninth Massachusetts, two of the last regiments arriving from the United States, were ordered to the front. The former was assigned to General Kent's division, and the latter to General Bates', which had also arrived." <sup>6</sup>

The United States and Spain agreed to an armistice on 12 August 1898. The 9th Massachusetts Volunteer Infantry stayed in Cuba until 26 August when they left to return to the United States, arriving on 4 September 1898. The regiment mustered out on 26 November 1898 at Boston.<sup>7</sup> The Spanish American War ended on 10 December 1898 with the Treaty of Paris.

#### **Irish Roots**

James Joseph McGrath was born on 26 February 1871 in Ballydwan, Kilmathomas, County Waterford, Ireland, the son of James McGrath and Bridget Keilly.<sup>8</sup> Bridget McGrath's brother was a chemist at the Dupont Company and sponsored James to come to the United States. James was approximately thirteen years old when he came to Massachusetts.<sup>9</sup>

#### Marriage

There he met Mary Eliza Leland, the daughter of Asa Leland and Anna Madden.<sup>10</sup> Mary E. Leland was born on 4 September 1880 in Plymouth, Plymouth County, Massachusetts.<sup>11</sup> Her family were residing in Plymouth until 1890 and by 1893, they had relocated to Worcester, Worcester County, Massachusetts.<sup>12,13</sup> James McGrath and Mary Leland, both residents of Worcester were married there on 16 September 1896, with Thomas S. Hanrahan, officiating.<sup>14</sup>

**1911 BOYLSTON PROPERTY DEED OF JAMES MCGRATH** Massachusetts Land Records

In 1900, James McGrath, an iron finisher, was residing on Mill Street in Worcester with his wife Mary McGrath.<sup>15</sup> On 24 January 1911 James J. McGrath, of the Town of Shrewsbury, purchased 3 tracts of land in Boylston from Lena F. Comerford. The deed describes the property to be at the crossroads of the Shrewsbury Road [Rt 140] and County Road [Rt 70] from Boylston to Worcester to the Schoolhouse.<sup>16</sup>

The 1920 U.S. Federal Census of Boylston lists the farm on Main Street [Rt 70], Boylston as the residence of James McGrath, a machinist in the mill industry. Living with him were: his wife Mary; daughter Etta, age 17 years; son John, age 15 years; daughter Anna, 14 years, and his mother Bridget McGrath, age 88 years. Frank Dunham, age 34 years; Dennis Gleason, age 44 years; and John Wade, age 38 years were boarders.<sup>17</sup>

The McGrath family in Boylston owned and operated a large pig farm on what is now Route 140, between the intersection with Route 70 and Sewall Streets. "The 600-1000 pigs on the farm were fed with food scraps collected from local hospitals. The pigs were sold to Hoffman's Meat Market in Clinton, Worcester County, Massachusetts".<sup>18</sup> James' mother, Bridget McGrath, died in Boylston in 1929.<sup>19</sup> The 1950 U.S. Federal Census lists James McGrath as farmer and head of

#### James J. McGrath, Spanish-American War Veteran, Dies

James J. McGrath, BJ of S Shrewsbury St. (formerly known as South Road), Boylston, died this morning in Rutland Veter-ans Administration Hospital. Mr. McGrath, a veteran of the Spanish - American War, was a noted runner in this area at the twen of the contury

years. He worked as a press hand at Worcester Stamped Metal Co. for 20 years before retiring in 1936. He previously was employed at Thomas Smith Co During the Spanish-American War he served in Cuba

#### Spanish American War Veteran Leaves a Legacy

James' wife, Mary Eliza McGrath died on 15 August 1957 in Worcester, Massachusetts and was buried in Hope Cemetery, Worcester, Massachusetts. James McGrath, 88 years old, of 26 Shrewsbury Street, Boylston died on 3 May 1962 at the Rutland Veterans Administration Hospital, Rutland, Massachusetts and was interred in the same gravesite as his wife who had predeceased him.<sup>20</sup> The family farm was left to his children: Etta M. Albinson, Anna M. Dunham and John F. McGrath. In 1963, one parcel was conveyed to the Town of Boylston to be used for the Elementary School and the other two parcels were sold; the area of the second two parcels later became the locations of the Atlas News, Inc. and Butler-Dearden Paper Service, Inc.<sup>21,22,23</sup>
